Privacy Notice

How we use your data

The personal data you provided on this form will be used by Stockport Grammar School to process your donation in accordance with our contractual and legal obligations, and to meet our legitimate interest of alumni and supporter engagement, fundraising and stewardship. We will use your data to: record information about your giving, including any gift agreements, memberships, or correspondence relevant to your donation; communicate with you about the impact of your donation and other appeals that may be of interest to you; record your updated contact details and mailing preferences; record your preferences regarding the external reporting of your donation; and record information about your willingness and capacity to support our charitable objectives, which may be provided by you or from information in the public domain.

Who has access to your data

The data you provided will be stored and shared across Stockport Grammar School in accordance with the School's policies and procedures. You have the right to object to the processing of your personal data at any time. The School is a "data controller", meaning you can contact the School if you have questions about your data. We may also need to share it with third parties supporting the processing of your transaction. We will only do this in appropriate circumstances, for specified purposes, by secure means, using the minimum amount necessary, and with the relevant data sharing agreements in place. We do not and will not sell your data.

Direct Debit Guarantee

- If there are any changes to the amount, date or frequency of your Direct Debit CTT Charity Payments Ltd will notify you 10 working days in advance of your account being debited, or as otherwise agreed.
